NOW, THEREFORE, OpenDNS and Cisco agree as follows and confirm that:



OpenDNS has assigned and transferred, and Cisco has received and accepted, all of OpenDNS' rights, title and interest throughout the world in and to the OpenDNS Marks and all the rights, claims and privileges pertaining to the OpenDNS Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the OpenDNS Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of OpenDNS in all matters related thereto.


OpenDNS hereby authorizes and requests the United States Commissioner of Patents and Trademarks to implement this Assignment.
