RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of June 30, 2016, by COMERICA BANK, a Texas banking association ("Lender") in favor of SUMMIT BHC STATESBORO, LLC, a Georgia limited liability company ("Statesboro") and WILLINGWAY, INC., a Georgia corporation ("Willingway"; with Statesboro, collectively, the "Companies") with their principal place of business located at 311 Jones Mill Road, Statesboro, GA 30458.

Recital

WHEREAS Companies have no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property Collateral.

Agreement


