
FIFTH: This Certificate of Merger, and the Merger, shall become effective as of 11:59 p.m. Eastern Time on December 31, 2015.



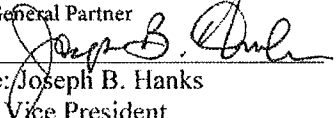


