NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is dated as of June 30, 2016 by CMS MEZZANINE DEBT SUBPARTNERSHIP, a Delaware general partnership (the "Lender") under that certain Senior Subordinate Note and Warrant Purchase Agreement, dated as of April 6, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Purchase Agreement") among Fortessa, Inc. (now known as Fortessa Tableware Solutions, LLC), a corporation formed under the laws of the Commonwealth of Virginia ("Fortessa"), Eschenbach, USA, Inc., a corporation formed under the laws of the Commonwealth of Virginia ("Eschenbach"), Sterling Housewares LLC (now known as Sterling Restaurant Supply, LLC), a Virginia limited liability company ("Sterling"), and Fortessa Intellectual Property, LLC (now known as Integrus Holdings, Inc.) a limited liability company formed under the laws of the Commonwealth of Virginia ("FIP"); collectively with Fortessa, Eschenbach, and Sterling, the "Borrowers"), and Lenders. Eschenbach and Fortessa are referred to herein each as a "Grantor" and together as the "Grantors").

WHEREAS, the Lender and the Grantors, entered into that certain Intellectual Property Security Agreement dated April 6, 2011 ("Security Agreement");

WHEREAS, under the Security Agreement the Grantors granted the Lender security interests in, among other things, such Guarantors' right, title and interest in the United States and foreign intellectual property rights identified on Schedules A attached hereto (the "Intellectual Property"), as security for the obligations of the Loan Parties, as defined in the Credit Agreement;

WHEREAS, the Lender recorded the Security Agreement with respect to the Intellectual Property listed on Schedule A-1 on July 1, 2011 in the United States Patent and Trademark Office ("PTO") at Reel 004574, Frame 0796;

WHEREAS, the Lender recorded the Security Agreement with respect to the Intellectual Property listed on Schedule A-2 on July 1, 2011 in the United States Patent and Trademark Office ("PTO") at Reel 004574, Frame 0782; and

WHEREAS, pursuant to that certain Payoff Statement, dated as of June 29, 2016, among the Borrowers and the Lender, Lender has agreed to terminate, release and discharge the security interests with respect to the Intellectual Property.

NOW THEREFORE, the Lender agrees as follows:

1. Defined terms used but not defined herein shall have the meanings attributed to such terms in the Security Agreement.
2. The Lender hereby:

(i) releases all liens and security interests with respect to the Intellectual Property;

(ii) re-assigns and releases to the applicable Grantor and terminates all right, title and interest that Lender has in and to the Intellectual Property and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including without limitation, all goodwill associated in any way with such Intellectual Property; and all the rights to sue for past, present and future infringements, and all rights corresponding thereto associated with such Intellectual Property;

(iii) waives and relinquishes all its rights, powers, privileges, and remedies with respect to the Grantors under the Security Agreement with respect to the Intellectual Property;

(iv) releases Grantors and their respective successors and assigns from all covenants, obligations, liabilities, and warranties under the Security Agreement.
