# TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of as of June 30, 2016 (the "Effective Date") from Bank of Montreal, as Administrative Agent for the benefit of certain lenders (in such capacity, the "Administrative Agent") to ANCILE Solutions, Inc. (the "Grantor").

**WHEREAS,** the Grantor was a party to a Security Agreement (as amended, modified or supplemented in accordance with its terms, the "Security Agreement") dated as of July 15, 2013 in favor of Administrative Agent and for the benefit of certain lenders;

**WHEREAS**, pursuant to the Security Agreement, the Grantor and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of July 15, 2013 (the "<u>IP Security Agreement</u>" all capitalized terms used, but not defined, herein have the definition assigned to them in the IP Security Agreement);

**WHEREAS,** pursuant to the IP Security Agreement the Grantor granted to Administrative Agent, for the benefit of the lenders, a security interest in and to all of the Grantor's right, title and interest (the "Security Interest") in the Grantor's Trademark Collateral (as hereinafter defined), including the trademarks and trademark applications listed on Exhibit A attached hereto (the "Released Marks"), and the goodwill associated therewith;

**WHEREAS,** the IP Security Agreement was recorded with the United States Patent and Trademark Office on July 17, 2013, at Reel 5072, Frame 0272; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent, on behalf of itself, its successors, legal representatives and assigns, without representation or warranty of any kind, express or implied, free and clear of any claims by Administrative Agent, (i) hereby releases and discharges fully its security interest in and to the Trademark Collateral, including the Released Marks, and retransfers to the Grantor, all of Administrative Agent's right, title and interest in and to the Trademark Collateral, including the Released Marks, the goodwill associated therewith, and all causes of action for past infringement, if any; and (ii) terminates the IP Security Agreement with respect to the Trademark Collateral, including the Released Marks.

The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest in, to and under the Released Marks, including the right to receive all proceeds therefrom and all other rights therein pledged or granted to the Administrative Agent under the Security Agreement and the IP Security Agreement.

The Administrative Agent shall take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, at the expense of the Grantor, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release.

This Release and the rights and obligations of the parties hereunder shall be construed in accordance with and be governed by the law of the State of New York, without regard to any conflicts of laws principles.

The Administrative Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks record this Release.


