RELEASE OF SECURITY INTEREST IN AND
ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN AND ASSIGNMENT OF INTELLECTUAL PROPERTY ("Assignment") made as of the 21st day of October, 2015, by WEBSTER BANK, NATIONAL ASSOCIATION, as agent ("Assignor"), in favor of PRECISION MANUFACTURING GROUP, LLC, a New Jersey corporation ("Assignee").

BACKGROUND

A. Assignee is the owner of certain intellectual property and other intangible property (collectively, "Intellectual Property"), including but not limited to inventions, designs, equipment formulations, manufacturing procedures, quality control procedures, trademarks, trademark applications, service marks, trade secrets, goodwill, copyrights, design rights, software, computer information, source codes, codes, records and updates, registrations, licenses, and customer lists, including certain issued patents as reflected on the records of the United States Copyright Office, all as more fully set forth on Exhibit "A" attached hereto and made a part hereof (collectively, the "Patents"), and certain trademarks and all goodwill therein, including certain registered trademarks and trademark applications as reflected on the records of the United States Patent and Trademark Office, all as more fully set forth on Exhibit "B" attached hereto and made a part hereof (collectively, the "Trademarks").

B. Pursuant to that certain Grant of Security Interest dated as of November 22, 2011 (as amended, supplemented or modified through the date hereof, together with all notes, mortgages, guarantees, subordination agreements, blocked account agreements, forbearance agreements and other documents and instruments relating thereto, collectively, the "Credit Agreement") among Assignee as "Grantor", the financial institution party thereto as "Lender" (the "Lender"), and Assignor, as agent for the Lender, the Lender established various credit accommodations for the benefit of Assignee on the terms and conditions set forth in the Credit Agreement.

C. In order to induce the Lender to enter into the Credit Agreement and establish such credit accommodations for the benefit of Assignee pursuant to the Credit Agreement, Assignee, among other things, granted to Assignor a lien on and security interest in the Intellectual Property, including the Patents and the Trademarks, pursuant to the Credit Agreement.

D. Assignor is hereby releasing its lien on, and all right, title and interest (if any) in and to, the Intellectual Property, including the Patents and the Trademarks, granted pursuant to, or in connection with, the Credit Agreement and is assigning all of its right, title and interest (if any) in and to the Intellectual Property, including the Patents and the Trademarks, to Assignee.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, intending to be legally bound hereby, covenants and agrees as follows:

1. Incorporation of Background. The Background provisions set forth above (including, without limitation, all defined terms set forth therein) are hereby incorporated herein by reference and made a part of this Assignment as if set forth in their entirety in this Section 1.

2. Release and Assignment. Assignor hereby irrevocably and unconditionally (a) releases, discharges, and relinquishes its lien on and security interest in any and all Intellectual Property, including all of the Patents and the Trademarks, and (b) assigns, transfers, conveys and sets over unto the Assignee any and all of Assignor's right, title and interest, if any, in, to and under the Intellectual Property, including all of the Patents and the Trademarks.


3. Further Actions. From time to time after the date hereof, and without further consideration, at the request and sole cost and expense of Assignee or its successors or assigns, Assignor shall promptly take such actions and execute and deliver such documents and instruments as Assignee, its successors or assigns, or their respective counsel, may reasonably request in order to perfect and record Assignee's (or its successors' or assigns') ownership rights in the Intellectual Property, including without limitation all of the Patents and the Trademarks.

4. Recording. Assignor hereby further authorizes and consents that this Assignment may be recorded and indexed by the United States Patent and Trademark Office and as otherwise deemed appropriate by Assignee or its successors or assigns.

5. Assignment. The rights granted to Assignee pursuant to this Agreement may be assigned without the prior written consent of Assignor to any purchaser of Assignee or any of its material assets.

IN WITNESS WHEREOF, Assignor has caused this Assignment to be duly executed and delivered as of the day and year first above written.
