RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") dated as of July 1, 2016, by Royal Bank of Canada, as Agent (in such capacity, the "Agent") under the Security Agreement referred to below.

WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Trademark Security Agreement dated as of August 1, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, and including all schedules thereto, the "Security Agreement"), Packaging Coordinators, Inc., Packaging Coordinators, LLC and AndersonBrecon Inc. (each, a "Grantor" and collectively, the "Grantors"), have granted to the Agent a security interest in the Grantors' right, title, and interest in the Trademark Collateral, including the trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded in the Assignment Recordation Branch of the United States Patent and Trademark Office at Reel: 5660; Frame: 0324; and

WHEREAS, at the request of the Grantors, the Agent has agreed to terminate and release its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the security interests, hereby agrees as follows:

1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Security Agreement.

2. Release. The Agent, without any recourse, representation, warranty (express or implied) or undertaking, hereby:

(a) terminates, releases and discharges any and all of its security interest in the Trademark Collateral, including without limitation, the trademarks set forth on Schedule 1 hereto;

(b) if, and to the extent that, the Agent has acquired any right, title or interest in and to the Trademark Collateral, reassigns, transfers, grants and conveys any and all of such right, title and interest to the applicable grantor;

(c) waives and relinquishes all of its rights, powers, privileges and remedies with respect to the Grantors and their successors and assigns in association with such security interest;

(d) releases the Grantors and their successors and assigns from all covenants, obligations, liabilities and warranties in association with such security interest; and

(e) authorizes this Release to be recorded with the United States Patent and Trademark Office.

3. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
