**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 30, 2016 (the "Termination and Release"), from **DEUTSCHE BANK AG, NEW YORK BRANCH** ("Agent"), as Administrative Agent and Collateral Agent for the several banks and other financial institutions that are parties to the Term Credit Agreement (as defined below), to **CINELEASE, INC., DOLLAR RENT A CAR, INC., DOLLAR THRIFTY AUTOMOTIVE GROUP, INC., DONLEN CORPORATION, THRIFTY, LLC, THE HERTZ CORPORATION, HERC RENTALS INC.** (f/k/a Hertz Equipment Rental Corporation), **HERTZ CLAIM MANAGEMENT CORPORATION** and **HERTZ SYSTEM, INC.** (each, a "Grantor").

**WHEREAS**, under the U.S. Guarantee and Collateral Agreement, dated as of March 11, 2011 (the "Term Guarantee and Collateral Agreement"), the Grantors granted to the Agent, for the ratable benefit of the Secured Parties (as defined therein), a security interest (the "Security Interest") in certain property, including the Trademarks (as defined below) applied for or registered with the U.S. Patent and Trademark Office (the "PTO") set forth on the schedules hereto;

**WHEREAS**, the grant of the Security Interest in the Trademarks was evidenced by (i) the Trademark Security Agreement, dated as of March 11, 2011, among the Agent, The Hertz Corporation, Hertz Equipment Rental Corporation, Hertz Claim Management Corporation and Hertz System Inc., (ii) the Trademark Security Agreement, dated as of March 30, 2012, between the Agent and Cinelease, Inc., (iii) the Trademark Security Agreement, dated as of February 22, 2013, between the Agent and Dollar Rent A Car, Inc., (iv) the Trademark Security Agreement, dated as of February 22, 2013, between the Agent and Dollar Thrifty Automotive Group, Inc., (v) the Trademark Security Agreement, dated as of January 19, 2012, between the Agent and Donlen Corporation, (vi) the Trademark Security Agreement, dated as of February 22, 2013, between the Agent and Thrifty, Inc. (the security agreements identified in the subclauses (i)-(vi), collectively the "Security Agreements");

**WHEREAS**, the Security Agreements were recorded in the Trademark Division of the PTO on the Reels and Frames listed on schedules hereto; and

**WHEREAS**, the Agent desires to terminate and release the entirety of its Security Interest in the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Term Guarantee and Collateral Agreement, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the parties hereto agree as follows:

SECTION 1. DEFINED TERMS.

1.1 Capitalized terms not otherwise defined herein have the meanings set forth in the Credit Agreement, dated as of March 11, 2011, among Hertz Equipment Rental Corporation, The Hertz Corporation, the Canadian Borrowers, the Lenders party thereto from time to time, the Agent, and certain other parties as named therein (as amended, supplemented or otherwise modified from time to time, the "Term Credit Agreement") or the Term Guarantee and Collateral Agreement, as applicable.

1.2 "Trademarks" shall mean all of the Grantors' United States and foreign trademarks, service marks, trade names, trade dress or other indicia of trade origin or business identifiers, trademark and service mark registrations, and applications for trademark or service mark registrations (except for "intent to use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Sections 1(c) and 1(d) of said Act has been filed, it being understood and agreed that the carve out in this parenthetical shall be applicable only if and for so long as a grant of a security interest in such intent to use application would invalidate or otherwise jeopardize Grantor's rights therein) (including, but not limited to, the trademarks listed on the schedules hereto), and any renewals thereof, including, without limitation, (i) the right to sue or otherwise recover for any and all past, present and future infringements or dilutions thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past or future infringements thereof), and (iii) all other rights corresponding thereto and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto in the United States, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress or other indicia of trade origin or business identifiers.

SECTION 2. RELEASE OF SECURITY INTEREST. The Agent hereby terminates, releases and discharges its Security Interest in the Trademarks, and any right, title or interest of the Agent in the Trademarks shall hereby cease and become void.

SECTION 3. RECORDATION. Each Grantor hereby authorizes and requests that the Commissioner of Trademarks of the United States record this Termination and Release with the PTO.

SECTION 4. FURTHER ASSURANCES. The Agent shall execute and deliver to the Grantors all further releases and other documents (including, without limitation, Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of the Security Interest in the Trademarks.

SECTION 5. GENERAL.

5.1 Governing Law. **THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER AND ANY CLAIM OR CONTROVERSY RELATING HERETO SHALL BE GOVERNED BY, AND**

**CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO ITS CONFLICT OF LAWS PROVISIONS.**

5.2 Successors and Assigns. This Termination and Release shall be binding upon and inure to the benefit of the Agent and Grantors and their respective successors and assigns.

5.3 Counterparts. This Termination and Release may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which when so executed, shall be deemed to be an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed page to this Termination and Release by facsimile transmission or other customary means of electronic transmission (including "pdf") shall be effective as delivery of a manually signed counterpart of this Termination and Release.
