SUPPLEMENTAL TRADEMARK COLLATERAL ASSIGNMENT
AND SECURITY AGREEMENT

July 1, 2016

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, IN MOCEAN GROUP, LLC, a New York limited liability company ("*Debtor*"), hereby grants to WELLS FARGO TRADE CAPITAL SERVICES, INC., a New York corporation, in its capacity as agent for certain lenders (in such capacity, "*Secured Party*"), a collateral security interest in and a general lien upon, and a conditional assignment of, the following: (a) all of Debtor's now existing or hereafter acquired right, title, and interest in and to: (i) trademarks, trade names, tradestyles and service marks; (ii) prints and labels on which said trademarks, trade names, tradestyles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature; and (iii) all applications, registrations and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, any political subdivision thereof or in any other countries, and all reissues, extensions and renewals thereof including the trademarks and trademark applications described in Schedule A hereto (the "*Trademarks*"); (b) the goodwill of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; (c) all income, fees, royalties and other payments at any time due or payable to Debtor with respect to any Trademarks, including, without limitation, payments under all licenses heretofore or at any time hereafter entered into by Debtor in connection therewith; (d) Debtor's right to sue for the past and present and future infringements thereof and all future infringements thereof; (e) all rights of Debtor corresponding thereto throughout the world; and (f) any and all other proceeds of any of the foregoing, including, without limitation, all damages and payments or claims by Debtor against third parties for past or future infringement of the Trademarks.

The security interest, lien and other interests granted to Secured Party pursuant hereto shall secure the prompt performance, observance and payment in full of all Obligations (as defined in the Trademark Collateral Assignment and Security Agreement, dated December 28, 2009 (as amended, supplemented and otherwise modified from time to time, the "*Trademark Agreement*"), between Debtor and Secured Party) of Debtor. The rights and remedies of Secured Party with respect to the security interest, lien and other interests granted to Secured Party pursuant hereto are as set forth in the Trademark Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions hereof are deemed to conflict with the Trademark Agreement, the provisions of the Trademark Agreement shall govern.


