## INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), effective the 10th day of August, 2011 (the "Effective Date"), is made and entered into by and between Liz Claiborne, Inc. and L.C. Licensing, Inc., each a Delaware corporation with principal place of business at 1441 Broadway, New York, New York 10018 (each an "Assignor" and collectively, "Assignors"), and Elizabeth Arden, Inc., a Florida corporation, with a place of business at 200 Park Avenue South, New York, New York 10003 ("Assignee"). Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in that certain License Agreement, dated as of May 28, 2008, by and among Liz Claiborne, Inc., Liz Claiborne Cosmetics, Inc., L.C. Licensing, Inc., Juicy Couture, Inc., and Lucky Brand Dungarees, Inc., each a Delaware corporation (each a Licensor, and collectively, "Licensor"), and Assignee (the "License Agreement"), as amended by that certain Amendment to License Agreement, dated as of August 10, 2011 (the "Amendment"), by and among Licensor and Assignee.

WHEREAS, Assignors own all right, title and interest in, and to the following (collectively, the "Purchased Intellectual Property"): (i) the trademarks, trade names, service marks and trademark applications and registrations set forth on **Exhibit A**, which is attached hereto, including all renewals and extensions thereof and all goodwill associated therewith (the "Purchased Marks"), (ii) all logos, trade dress, copyrights or copyrighted works, (including without limitation, trade dress rights, copyrights and copyrighted works in labels, packaging, or product design or configuration that are solely used in Licensed Products using the Purchased Marks, such products shall be referred to as the "Purchased Marks Products"), and any Internet domain names utilizing solely the Purchased Marks, and (iii) any trade secrets, know-how, formulas, compositions and technical data owned by Assignors related to the Purchased Marks Products; for purposes of clarity, the Purchased Marks do not include any trademarks, trade names, service marks and trademark applications, registrations or goodwill associated therewith other than those specifically set forth in **Exhibit A** for goods in International Class 3; and

WHEREAS, Assignee desires to acquire and assume from Assignors the Purchased Intellectual Property, and Assignors desires to sell and assign such Purchased Intellectual Property, in each case in accordance with the terms and subject to the conditions set forth in the License Agreement, as amended by the Amendment.

NOW THEREFORE, for the consideration set forth in the Amendment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee agree as follows:

1. Assignment. Effective upon execution and delivery by Assignors and Assignee of the Amendment and certain other documents set forth therein, Assignors hereby sell, assign, transfer and convey to Assignee all of Assignors' right, title and interest in, to and under the following property throughout the world:

- (a) the Purchased Intellectual Property, including all rights therein provided by international conventions and treaties (including the material relevant supporting documents, such as file wrappers, registration, renewal and/or annuity confirmations, if any) ("Transferred Rights");
- (b) all rights to bring any action at law or in equity for the past infringement of Purchased Intellectual Property occurring prior to the Effective Date, including the right to receive all proceeds and damages or other remedies therefrom; and
- (c) any and all rights to royalties, profits, compensation, license fees or other payments or remuneration of any kind relating to the Transferred Rights, to the extent they exist, arising from and after the date of this Assignment.

Assignee, its successors and assigns, shall hold the rights to the foregoing for and during the existence of such Transferred Rights, and all renewals, reissues and extensions thereof, as fully and as entirely as the same would have been held and enjoyed by Assignors had this Assignment not been made.

2. Further Assurances. Assignors shall timely execute and deliver any additional documents and perform such additional acts reasonably necessary or desirable, in all cases in accordance with the terms set forth in the Amendment, to record and perfect the interest of Assignee in and to the Purchased Intellectual Property, and shall not enter into any agreement in conflict with this Assignment.

3. Governing Law. Except to the extent that U.S. federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of New York, without regard to the conflicts of law rules of such state.

4. Purpose. This Assignment has been granted to Assignee in connection with the Amendment and is expressly subject to the terms and conditions thereof. In case of any conflict between the terms of this Assignment and the Amendment, the terms of the Amendment shall control.

5. Counterparts. This Assignment may be executed by facsimile in any number of counterparts, each of which shall be deemed to be an original all of which constitute one and the same agreement.
