FIRST SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement to Intellectual Property Security Agreement (this "Supplement") is made as of the 30th day of June, 2016 by ZOCDOC, INC., a Delaware corporation (the "Grantor") in favor of SILICON VALLEY BANK (the "Grantee").

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated March 26, 2015, and recorded with the U.S. Trademark Office on March 27, 2015 at Reel 5486, Frame 0534, as corrected by that certain Corrective Assignment recorded on April 13, 2015 at Reel 5496, Frame 0263 and recorded with the U.S. Patent Office on April 13, 2015 at Reel 035412, Frame 0001 (as amended from time to time hereinafter, the "Grant") in favor of the Grantee, pursuant to which the Grantors pledged, assigned and granted a security interest in certain Intellectual Property Collateral (as defined therein); and

WHEREAS, the Grantor has developed additional Intellectual Property Collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Intellectual Property Collateral in favor of the Grantee; and

WHEREAS, the Grantor has abandoned a certain patent application (as specified below in Section 2(a) of this Supplement) not material to Grantor's business.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.

2. Supplement to Exhibits.

a. The following item listed in Exhibit B to the Grant is hereby deleted:

- b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.


