international conventions and treaties, the right to sue for damages and other remedies in respect of future infringement thereof, together with the goodwill of the business pertaining to said marks, the same to be held and enjoyed by Chemport, Inc., its successors and assigns.

(b) C.S.I. Chemical Corporation shall take all actions and execute all documents reasonably requested by Chemport, Inc. to record and perfect the interest of Chemport, Inc. in and to the Marks. Such documents may include, but may not be limited to: powers of attorney, letters of instruction to the agents to inform them of this assignment and acknowledgments thereof from the agents, as well as providing to Chemport, Inc. a list of the agents used by country and status of the current Marks (docket report). All out-of-pocket expenses associated with preparing and recording assignments, including all legalization and notarization costs, shall be borne by C.S.I. Chemical Corporation.
