INTELLECTUAL PROPERTY SECURITY AGREEMENT

INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of June 30, 2016 (this "Agreement"), made by EAPEIRON SOLUTIONS INC., a Delaware corporation (the "Grantor"), in favor of ALIBABA.COM US INVESTMENT HOLDING CORP., a Delaware corporation ("Alibaba"), in its capacity as the Purchaser Representative (as defined in the Note Purchase Agreement described below) for the benefit of the Secured Parties (as defined in the Note Purchase Agreement described below) (Alibaba, in such capacity, the "Purchaser Representative").

RECITALS

WHEREAS, the Grantor, the Purchasers under and as defined therein, the Purchaser Representative and Eastman Kodak Company are parties to that certain Note Purchase Agreement, dated as of June 30, 2016 (such agreement, as amended, restated, amended and restated, supplemented or otherwise modified from time to time, including any replacement agreement therefor, being hereinafter referred to as the "Note Purchase Agreement");

WHEREAS, reference is hereby made to the Security Agreement dated as of June 30, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"; capitalized terms used but not otherwise defined herein having the respective meanings herein as set forth therein) pursuant to which the Grantor granted a continuing security interest in all of Grantor's right, title and interest in and to the Collateral, including the Intellectual Property, to secure the payment and performance of the Secured Obligations.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Section 1. Grant of Security Interest. As security for the payment and performance of the Secured Obligations, the Grantor hereby grants to the Purchaser Representative, for the benefit of the Secured Parties, a continuing security interest in all of Grantor's right, title and interest, whether now owned or existing or hereafter acquired or arising, in and to any and all items of Intellectual Property (including, without limitation, those patents, patent applications, trademarks and trademark applications listed on Exhibits A and B, respectively, attached hereto) together with all substitutions and replacements thereof and any products and Proceeds (as defined in the UCC) thereof.


Section 2. Security Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the Security Interest granted to the Purchaser Representative for the benefit of the Secured Parties pursuant to the Security Agreement and the Grantor hereby acknowledges and affirms that the rights and remedies of the Secured Parties with respect to the security interest in the Intellectual Property made and granted hereby are more fully set forth in the Security Agreement, the terms of which are incorporated herein by reference. In the event that any provision of this Agreement conflicts with or is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control unless the Purchaser Representative shall otherwise determine.

Section 3. Governing Law. This Agreement and any controversy arising out of or related thereto shall be governed by, and construed in accordance with, the laws of the State of New York.

Section 4. Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which when taken together shall constitute one and the same contract. This Agreement may be executed and delivered by facsimile, or by email in portable document format (.pdf) and delivery of the signature page by such method will be deemed to have the same effect as if the original signature had been delivered to the other parties.

IN WITNESS WHEREOF, the undersigned parties have caused this Intellectual Property Security Agreement to be executed as of the date first written above.


