RELEASE OF SECURITY AGREEMENT
PATENTS, TRADEMARKS AND COPYRIGHTS

THIS RELEASE by FIRST NATIONAL BANK OF PENNSYLVANIA, a national banking association ("Lender"), as the lender under and pursuant to that certain Patent, Trademark and Copyright Agreement dated December 21, 2012, by and between Lender and NABCO, INC., a Pennsylvania corporation ("NABCO").

WITNESSETH:

WHEREAS, on December 21, 2012, NABCO executed and delivered in favor of Lender (1) a Patent, Trademark and Copyright Security Agreement (the "Security Agreement") dated December 21, 2012, (2) a Notice of Security Interest in U.S. Patents (the "Patent Notice") recorded in the United States Patent and Trademark Office (the "Office") on January 4, 2013 at Reel 29572, Frame 530, and (3) a Notice of Security Interest in U.S. Trademarks (the "Trademark Notice") dated December 21, 2012 recorded in the Office on January 4, 2013 at Reel 4936, Frame 87.

WHEREAS, in the Security Agreement, and as reflected in the Patent Notice and the Trademark Notice, NABCO assigned to Lender and pledged and granted a lien and security interest to Lender, in, inter alia, patents and trademarks of NABCO, including without limitation, the patents shown on Exhibit A attached hereto, and the trademarks shown on Exhibit B attached hereto and all rights related thereto in order to secure the satisfaction of the Obligations (as such term is defined in the Security Agreement);

WHEREAS, the Obligations have been satisfied or satisfactory arrangements for the satisfaction thereof have been made and Lender desires to release its rights created by the Security Agreement and reflected in the Patent Notice and the Trademark Notice;

WHEREAS, the attached Exhibits A and B identify all the specific trademarks or patents which were the subject of the Security Agreement and reflected in the Patent Notice and the Trademark Notice; and


WHEREAS, Lender has not granted any license, right or privilege with respect to any of the patents or trademarks which were the subject of the Security Agreement and reflected in the Patent Notice and the Trademark Notice, and has not encumbered such rights in any other way.

NOW, THEREFORE, for valuable consideration, receipt of which is hereby acknowledged, Lender does hereby release, cancel and annul its entire right and interest created by the Security Agreement, including, without limitation, the patents and trademarks identified in the Patent Notice and the Trademark Notice and as referenced in the attached Exhibits A and B.

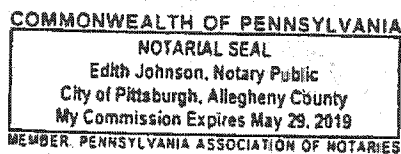
