**TRADEMARK ASSIGNMENT**

This **TRADEMARK ASSIGNMENT** is made and entered into as of October 5th, 2015, between Johnson & Johnson, a New Jersey corporation, having its principal place of business at One Johnson & Johnson Plaza, New Brunswick, NJ 08933 USA ("Assignor") and OXY'PHARM SARL, Société à responsabilité limitée, a French company with having its principal place of business at 917 rue Marcel Paul, 94500, Champigny-sur-Marne, France (the "Buyer" and "Assignee").

**WHEREAS**, pursuant to and subject to the conditions set forth in that certain Umbrella Purchase Agreement, dated as of July 1, 2015 (the "Purchase Agreement"), by and among Buyer and Gloster Europe SAS, a société par actions simplifiée organized under the laws of France, having its principal place of business at 9 Avenue de l'Europarc B18, 31520 Ramonville St-Agne, France ("Seller"), Seller has agreed, and has agreed to cause Seller's Affiliates to, sell, convey, assign, and transfer to Buyer, and Buyer has agreed to purchase, acquire and accept, certain Purchased Assets, including Assignor's worldwide right, title and interest in, to and under the trademarks set forth on Schedule A annexed hereto (hereinafter referred to as the "Transferred Trademarks"). Each capitalized term used and not defined in this Trademark Assignment shall have the meaning assigned to it in the Purchase Agreement; and

**WHEREAS**, in accordance therewith, Assignor desires to sell, convey, assign and transfer to Assignee, and Assignee desires to purchase, acquire and accept, all of Assignor's worldwide right, title and interest in, to and under such Transferred Trademarks.


**NOW, THEREFORE**, Assignor, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, does hereby assign and transfer to Assignee, and Assignee hereby acquires and accepts, all of Assignor's right, title and interest in, to and under the Transferred Trademarks identified on Schedule A, and all the rights appurtenant thereto, together with the goodwill associated therewith and which is symbolized thereby, all of Assignor's rights and actions for past infringement and/or misappropriation, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, and in any other jurisdiction identified on Schedule A, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had this Trademark Assignment not been made.

For a period of up to 12 months from the date hereof, (i) Assignor agrees to provide to Assignee the necessary information and execute applicable country trademark assignment agreements prepared by Assignee to permit Assignee at Assignee's expense to effect and perfect the transfer of the applications and registrations of the Transferred Trademarks, and (ii) Assignor agrees to reasonably cooperate with Assignee in filing appropriate documents to cancel all "registered user" filings that are in favor of Assignor or any of its Affiliates or any third party in the jurisdictions identified on Schedule A, if any. To the knowledge of Assignor, the list of Transferred Trademarks against which a registered user is recorded are identified on Schedule B. Assignor agrees not to prevent the Assignee from enjoying it's right to the Transferred Trademarks based on the rights provided in any registered user Agreement, which may be recorded against any of the Transferred Trademarks. After such period Assignor shall have no further obligation hereunder.


