**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS, TRADEMARKS AND COPYRIGHTS**

THIS TERMINATION AND RELEASE dated as of June 30, 2016, is granted by PNC BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Agent") for certain lenders, in favor of GOLDEN SUN, INC., a California corporation ("Golden Sun").

WITNESSETH:

WHEREAS, pursuant to (i) the Second Amended and Restated Credit Agreement (as amended, restated, amended and restated, modified or supplemented from time to time), dated as of April 11, 2014, made by and among the Agent, High Ridge Brands Co., a Delaware corporation ("High Ridge"), the Guarantors party thereto, the Lenders party thereto, and PNC Bank, National Association, as Administrative Agent; (ii) the First Amendment and Consent to Second Amended and Restated Credit Agreement, dated as of May 1, 2015, by and among High Ridge, each of the Guarantors party thereto, the Lenders (as defined therein), and PNC Bank, National Association as Agent, and (iii) the Patent, Trademark and Copyright Security Agreement, dated as of May 1, 2015, made by and between the Agent and Golden Sun (the "2015 PTC Security Agreement"), security interests (the "Security Interest") were granted by Golden Sun in favor of the Agent in certain collateral, including certain Intellectual Property Collateral (as hereinafter defined);

WHEREAS, the 2015 PTC Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 11, 2015 at Reel 5513 Frame 0813; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Intellectual Property Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Intellectual Property Collateral," as used herein, shall mean all of Golden Sun's right, title and interest of every kind and nature as of the date hereof in all trade names, patent applications, patents, trademark applications, trademarks and copyrights, including without limitation those listed on Schedule A hereto, including all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the good will with the use of, and symbolized by, connected with the business to which any of the Intellectual Property Collateral relates.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Intellectual Property Collateral, and any right, title or interest of the Agent in such Intellectual Property Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
