RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Payoff Letter dated as of July 1, 2016 between Madison and Company, Madison has agreed to terminate and release the Trademark Security Agreement as provided herein.

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Madison hereby terminates and releases the Trademark Security Agreement, and Madison hereby terminates, releases, and discharges its liens on and security interests in, to, and under the Trademark. Madison hereby reassigns, grants and conveys to the Company, without any representation, recourse or


undertaking by Madison, any and all of Madison's right, title and interest in and to the Trademark.
