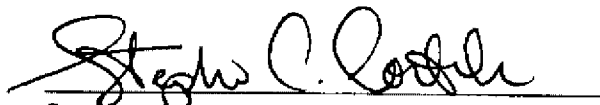
2. The Certificate of Incorporation of the Corporation is hereby amended by striking out Article numbered **First** thereof and by substituting in lieu of said Article the following new Article:
