ASSIGNMENT OF TRADEMARKS

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record the right to the TRADEMARKS as listed in the annexed SCHEDULE OF TRADEMARKS as the property of ASSIGNEE; and

ASSIGNOR further agrees to execute such further documents as may be required to record and/or establish ASSIGNEE as the owner of the TRADEMARKS, and all rights herein assigned.
