## SERVICE MARK ASSIGNMENT

THIS SERVICE MARK ASSIGNMENT (this "Assignment") is entered into as of the 5<sup>th</sup> day of July, 2016, by and between Hook Law Center PC, a Virginia professional corporation ("Assignor"), and James A. Scott & Son, Incorporated, a Virginia corporation ("Assignee").

WHEREAS, Assignor, to the best of its knowledge and belief, owns the entire right, title and interest in and to U. S. Service Mark Registration No. 3,738,851 (the "Registration"), issued January 19, 2010, for the Service Mark TRIAGESR (the "Mark") in International Classes 36 and 45, together with the goodwill of the business connected with and symbolized by the Mark; and

WHEREAS, Assignor and Assignee are parties to a cancellation proceeding before the Trademark Trial and Appeal Board, Cancellation No. 92062152 (the "Cancellation"); and

WHEREAS, simultaneously with the execution of this Assignment, Assignor and Assignee have entered into a Settlement Agreement resolving the Cancellation, and as part of the consideration for such settlement, Assignor has agreed to assign to Assignee all of Assignor's right, title and interest in and to the Mark on the terms and conditions set forth herein.

NOW, THEREFORE, for good and valuable consideration, including the resolution of disputed claims and other monetary consideration, the receipt and sufficiency of which are acknowledged:

1. Assignor hereby sells, assigns, transfers and conveys to Assignee, its successors and assigns, all of Assignor's right, title, and interest, whether statutory or at common law, in and to (i) the Mark, together with all the goodwill of the business in connection with which the Mark has been used in the United States and in all countries throughout the world, and all claims related thereto, if any, which may have arisen prior to the date of this Assignment and (ii) all benefits, privileges, causes of action, common law rights, and remedies relating thereto throughout the world, including, without limitation, all of Assignor's right to: (a) apply for and maintain all registrations, renewals, and/or extensions thereof, (b) bring actions and recover damages for past, present, and future infringement or other violation thereof, and (c) grant licenses or other interests therein.

2. Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record this Assignment memorializing the transfer of the Mark, including the Registration for the Mark, to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Mark.

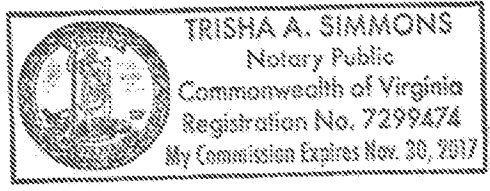
