**TERMINATION OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination of Intellectual Property Security Agreement (the "Termination") is made as of June 30, 2016, by and among (a) **LIVEU INC.**, a Delaware corporation, with its principal place of business at 2 University Plaza Drive, Suite 505, Hackensack, New Jersey 07601 ("Grantor") and (b) **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 275 Grove Street, Suite 2-200, Newton, Massachusetts 02466, and **KREOS CAPITAL IV (EXPERT FUND) LIMITED**, a company with limited liability incorporated in Jersey under registered number 05981165 whose registered office is at 47 Esplanade, St. Helier, Jersey (collectively, "Lenders") in consideration of the mutual covenants herein contained and benefits to be derived herefrom.

WITNESSETH:

WHEREAS, Grantor and Lenders entered into a certain Intellectual Property Security Agreement dated as of April 14, 2014 and filed with the U.S. Patent and Trademark Office on April 17, 2014 at Reel 5262, Page 0701 (the "IP Agreement"), pursuant to which Grantor pledged, granted and assigned security interests in favor of Lenders in the Intellectual Property Collateral; and

WHEREAS, the parties wish to terminate the IP Agreement.

NOW, THEREFORE, it is hereby agreed that the IP Agreement shall be terminated as of the date first written above. The parties authorize and request that the U.S. Patent and Trademark Office note and record the existence of this Termination.


