TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of June 28, 2016 (this "Termination and Release"), from Wilmington Trust, National Association (successor by merger to Wilmington Trust FSB) in its capacity as Collateral Agent (the "Agent"), to Festival Fun Parks, LLC, a Delaware limited liability company and Wonderland Amusement Management, LLC, a Pennsylvania limited liability company (the "Grantors").

WITNESSETH:

WHEREAS, the Grantors are party to a Pledge and Security Agreement, dated as of February 28, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement"), among Palace Entertainment Holdings, LLC (the "Borrower"), the other entities from time to time party thereto and the Agent, pursuant to which the Grantors granted a security interest (the "Security Interest") to the Agent in the Trademark Collateral (as defined below);

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantors and the Agent entered into the Trademark Security Agreement, dated as of February 28, 2011 (the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 9, 2011, at Reel 4493 and Frame 0271; and

WHEREAS, the Agent now desires to terminate and release the entirety of the Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all indebtedness and other obligations secured by the Trademark Collateral, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of each Grantor's right, title and interest of every kind and nature in, to and under the Trademarks listed on Schedule A hereto, including the right to receive all Proceeds therefrom. Unless otherwise defined herein or the context otherwise requires, terms used in this Termination and Release, including the preamble and the recitals, have the meanings provided or provided by reference in the Pledge and Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges the Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in the Trademark Collateral shall hereby cease and become void.
