**SECOND:** The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by the surviving limited liability company and the merging corporation.


**THIRD:** The name of the surviving limited liability company is Precyse Solutions, L.L.C. which shall amend its name to nThrive Solutions, LLC.
