## TRADE MARK AND DOMAIN NAME ASSIGNMENT AGREEMENT

This Trade Mark and Domain Name Assignment Agreement (the "Agreement") is entered into as of the date last executed below (the "Effective Date") by and between Les Produits Techniseal Inc. ("Techniseal"), the full post office address of whose principal office or place of business is 300 Avenue Liberté, Candiac, Quebec J5R 6X1, Canada, and Oldcastle Building Products Canada, Inc. ("Oldcastle"), the full post office address of whose principal office or place of business is 8145 Rue Bombardier, Montréal, Quebec H1J 1A5, Canada. Techniseal and Oldcastle may be collectively referred to as the "Parties."

WHEREAS, Techniseal has adopted and used, or has a bona fide intention to use, and is the owner of certain trade marks, including applications and registrations therefor, and all the goodwill arising therefrom, as listed in **Schedule 1** (collectively, "the Trade Marks");

WHEREAS, Techniseal is the owner of certain domain names, as listed in **Schedule 2** (the "Domain Names");

WHEREAS, Techniseal, by virtue of that certain Asset Purchase Agreement between the Parties, being executed concurrently herewith, is interested in assigning the Trade Marks and Domain Names to Oldcastle;

WHEREAS, Oldcastle, by virtue of the aforementioned Asset Purchase Agreement, as successor-in-interest to that portion of the business of Techniseal, which is ongoing and existing, associated with the Trade Marks and Domain Names, is desirous of acquiring all right, title, and interest in and to the same, including the goodwill associated therewith;

NOW THEREFORE, in consideration of the sum of Ten Canadian Dollars, and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties agree as follows:

1. Techniseal hereby irrevocably assigns and transfers to Oldcastle, and Oldcastle hereby accepts, all right, title and interest in and to the Trade Marks, including but not limited to the right to enforce them against any infringement occurring before or after the Effective Date, together with the goodwill of the business associated with the Trade Marks, the same to be held by Oldcastle, as fully and effectually as they would have been held by Techniseal had this assignment not taken place.

2. Oldcastle will be entitled to register this Agreement at the relevant intellectual property offices. Techniseal shall give Oldcastle any powers and authorization necessary for this purpose and, at the request of Oldcastle or its designee, shall execute any further documents necessary to give full effect to this Agreement. The expenses of such registrations and additional documents will be borne by Oldcastle.

3. Techniseal hereby assigns and transfers to Oldcastle, and Oldcastle hereby accepts, all right, title and interest in and to the Domain Names, including but not limited to the right to pursue all causes of action arising out of or related to the rights in and to the Domain Names, whether arising before or after the Effective Date, the same to be held by Oldcastle, as

fully and effectually as they would have been held by Techniseal had this assignment not taken place.

4. After execution and delivery of this Agreement, Techniseal will execute any paperwork or electronic forms required by the Registrars to transfer the Domain Names to Oldcastle and shall otherwise cooperate as necessary to transfer the Domain Names.

5. If any term of this Agreement shall be found to be illegal, invalid, or unenforceable by a court of competent jurisdiction, it is the intention of the Parties that the remaining terms shall constitute their agreement with respect to the subject matter, and all such remaining terms shall remain in full force and effect. This Agreement shall be governed by and construed under the laws of Canada without regard to its provisions relating to the conflict of laws. Any dispute arising in connection with this Agreement shall be submitted to the exclusive jurisdiction of the Courts of Quebec, Canada. This Agreement constitutes the entire agreement between Oldcastle and Techniseal with respect to the subject matter and shall not be modified, amended, or terminated unless in writing and signed by or on behalf of each of the Parties.

IN WITNESS WHEREOF, the Parties, intending to be legally bound by this Agreement, have each caused this Agreement to be executed by individuals authorized to legally bind the Parties, effective as of the Effective Date.

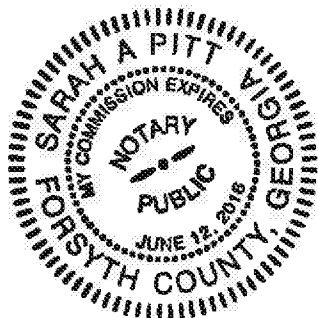


