RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE of Intellectual Property Security Agreement (“Release of IP Security”) is executed as of July 15, 2016, by Security Benefit Corporation, as agent for the Lenders (the “Agent”), for the benefit of Abbey Restaurants and Bars USA, LLC (the “Grantor”).

WHEREAS, pursuant to the intellectual property security agreement, dated as of December 2, 2014 (the “First Lien IP Security Agreement”), between, *inter alios*, the Grantor and the Agent, which First Lien IP Security Agreement was recorded in the U.S. Patent and Trademark Office on December 5, 2014 at 5412/0139, the Grantor has granted a security interest in its right, title and interest in and to the Trademark Collateral (as defined in the First Lien IP Security Agreement), including, without limitation, the intellectual property listed in Annex I hereto (together with any and all other Trademark Collateral owned by the Grantor, hereinafter referred to collectively as the “Released Intellectual Property”) to the Agent; and

WHEREAS, in connection with the discharge of all liabilities and obligations, the Agent, on behalf of the Lenders, has agreed to release the security interests created over the Released Intellectual Property on the terms and conditions set forth in that certain Release Agreement, dated as July 15, 2016, between, among others, the Grantor, SBE Restaurant Group, LLC and the Agent.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases the security interests over the Released Intellectual Property created by the IP Security Agreement as of the date first written above.
