Pursuant to Title 8, Section 252 (c) of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Teledyne Instruments, Inc., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is Teledyne Bolt, Inc., a Connecticut corporation.

FIFTH: The authorized stock and par value of the non-Delaware corporation is 1,000 common shares at \$.01 per share.


SIXTH: The merger is to become effective at 12:01 a.m. (EST) on July 4, 2016.
