NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of July 7, 2016, is made with regard to C. G. BRETTING MANUFACTURING CO., INC., a Wisconsin corporation (the "Debtor"), having an address for notice at 3401 Lake Park Road, Ashland, Wisconsin 54806-4967, and WELLS FARGO BANK, NATIONAL ASSOCIATION ("Lender"), having an address for notice at 730 - 2nd Avenue S., 8th Floor, Minneapolis, Minnesota 55402.

R E C I T A L S :

The Debtor and the Lender have entered into a Credit and Security Agreement dated as of June 28, 2016 (as the same may hereafter be amended, supplemented or restated from time to time, the "Credit Agreement") setting forth the terms on which the Lender may now or hereafter make certain loans or other financial accommodations to or for the account of the Debtors.
