
1. Spell was the initial collateral agent for certain lenders under the terms of the Note Purchase and Security Agreement (Term B Notes), among Spell, Sellars and others (the "Note Purchase Agreement").
2. Spell and Sellers entered into an Intellectual Property Security Agreement as of June 12, 2013 ("Security Agreement") which was recorded against certain intellectual property in the U.S. Patent and Trademark Office.
3. Spell has resigned as the collateral agent under the Note Purchase Agreement and SMDI has been appointed as the new collateral agent under the Note Purchase Agreement.
4. Any references in the Security Agreement to "Spell" in its capacity as agent shall mean and be a reference to "SMDI" in its capacity as successor agent.


