ARTICLES OF AMENDMENT

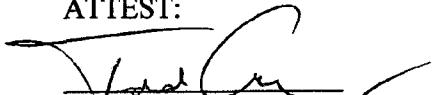

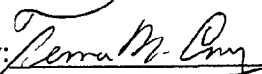

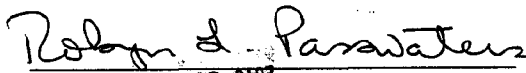
