INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (“Assignment Agreement”) is made effective as of June 20, 2016 (the “Effective Date”), by and among **FRIENDLY’S IP, LLC**, a Delaware limited liability company (“Friendly’s IP”), **FRIENDLY’S ICE CREAM, LLC**, a Delaware limited liability company (“FIC,” and together with Friendly’s IP, “Assignors”), and **FRIENDLY’S MANUFACTURING AND RETAIL, LLC**, a Delaware limited liability company (“Assignee”).

WHEREAS, Assignee is engaged in the business of developing, producing, manufacturing, marketing, distributing and selling ice cream and other frozen dessert related products, as well as toppings for the foregoing (the “Business,” provided that, for the avoidance of doubt, the Business shall not include the ownership or operation of restaurants, including any and all assets used or held for use primarily in connection with the ownership or operation of restaurants).

WHEREAS, Friendly’s IP and Assignee are wholly-owned subsidiaries of FIC.

WHEREAS, FIC is a wholly-owned subsidiary of Friendly’s Ice Cream Holdings Corp., a Delaware corporation (the “Holdings”).

WHEREAS, Neapolitan Group Holdings, LLC, a Delaware limited liability company (“Seller”), owns 100% of the issued and outstanding equity interests of Holdings.

WHEREAS, Seller and Dean Foods Company (the “Purchaser”) have entered into a Stock Purchase Agreement, dated as of May 9, 2016, as amended by that certain First Amendment dated as of the date hereof (as amended, the “Purchase Agreement”), pursuant to which the Purchaser will purchase the Business from Seller through an acquisition of 100% of the issued and outstanding shares of common stock, par value \$0.001 per share, of Holdings (the “Transaction”).




WHEREAS, immediately prior to and as a condition to the consummation of the Transaction, Assignors agreed to convey, assign, transfer, and deliver to Assignee all of Assignors’ right, title, and interest in, to, and under the any intellectual property owned by Assignors and used by Assignee in the business of developing, producing, manufacturing, marketing, distributing, and selling ice cream and other frozen dessert-related products, as well as toppings for the foregoing, excluding the intellectual property set forth on the Divested Assets Schedule to the Purchase Agreement, and including: (i) the trademark applications and registrations specified on Schedule A hereto (the “Registered Trademarks”), (ii) the unregistered trademarks specified on Schedule B hereto, (iii) the recipes, formulae and/or product packaging associated with the retail products specified on Schedule C hereto, and (iv) the domain names specified on Schedule D hereto (collectively, the “Assigned IP”).

WHEREAS, in connection with the Transaction, and subsequent to the effectiveness of this Assignment Agreement, FIC shall merge with and into Friendly's Ice Cream II, LLC ("FIC II"), with FIC II being the surviving entity (the "Merger"), and the transactions contemplated by this Assignment Agreement shall occur prior to the Merger.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignors hereby convey, assign, transfer and deliver to Assignee, and Assignee hereby acquires, and accepts from Assignors, all of Assignors' right, title, and interest in, to, and under the Assigned IP, including all goodwill associated therewith, all copyright and trade secret rights included in the Assigned IP, and all rights of action and remedies for past, present, and future infringements of any of the Assigned IP, the same to be held and fully enjoyed by Assignee, its successors, assigns and other legal representatives.
2. The Assignors shall execute and deliver any and all instruments and documents and take such further actions as may be necessary or reasonably requested by the Assignee to document and record with the appropriate authorities the aforesaid assignment and transfer, including all steps that may be reasonably necessary to effect the foregoing assignment and transfer of the domain names specified on Schedule D hereto in accordance with the domain name transfer procedures of the applicable domain name registrar(s).
3. Friendly's IP hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America, and any other applicable governmental authority, to issue or transfer all Registered Trademarks to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct. Assignee shall have the right to record this Assignment Agreement with all applicable government authorities so as to perfect its ownership of the Registered Trademarks.
4. This Assignment Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
