**TERMINATION OF PATENTS, TRADEMARKS
AND COPYRIGHTS SECURITY AGREEMENT
AND RELEASE OF SECURITY INTEREST**

This TERMINATION OF PATENTS, TRADEMARKS AND COPYRIGHTS SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST (this "Release"), dated as of July ____, 2016, is made by and between SABERT CORPORATION, a New Jersey corporation, having its principal office at 2288 Main Street Extension, Sayreville, New Jersey 08872 ("Grantor"), and PNC BANK, NATIONAL ASSOCIATION, as Administrative Agent, having offices at Two Tower Center, East Brunswick, New Jersey 08816 ("Secured Party").

WITNESSETH

WHEREAS, pursuant to the Patents, Trademarks And Copyrights Security Agreement, dated as of November 9, 2007, recorded with the U.S. Patent and Trademark Office on November 20, 2007 at Trademark Reel/Frame No. 3664/0927, and at Patent Reel/Frame No. 020134/0538, as amended by the First Amendment to Patents, Trademarks And Copyrights Security Agreement, recorded with the U.S. Patent and Trademark Office on January 31, 2012 at Patent Reel/Frame No. 027622/0776, (collectively, the "Security Agreement"), the Grantor granted the Secured Party a collateral security interest in, all of its right, title and interest in, to certain patents, trademarks and copyrights specified therein) pledged by the Grantor, including, without limitation, (A) the United States patents set forth on Schedule A attached hereto (collectively, the "Patents"), and (B) the United States trademarks set forth on Schedule B attached hereto (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by, the Trademarks;

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Secured Party; and

WHEREAS, the Grantor has requested that the Secured Party release its collateral security interest in all right, title and interest of the Secured Party in and to the Patents and Trademarks;

NOW, THEREFORE, the Secured Party, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby:

- (1) terminates, cancels and releases its collateral security interest in and to the Patents and Trademarks, as well as all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and any and right, title and interest of the Secured Party in the Patents and Trademarks shall hereby terminate, cease and become void; and
- (2) authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record this Release hereby given.

The Secured Party agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Secured Party's security interest in the Patents and Trademarks.


