**TERMINATION AND RELEASE OF
SECURITY INTERESTS IN TRADEMARKS**

This Termination and Release (the "Termination and Release") is granted as of November 27, 2013, from Citicorp USA, Inc. as collateral agent (the "Collateral Agent") for the banks and other financial institutions that are parties to the Credit Agreement dated August 1, 2006, to Davis Vision, Inc.; Davisvision IPA, Inc.; Davis Vision of Nevada Inc.; DVSC, Inc.; Empire Vision Center, Inc.; Viva Optique, Inc.; Viva Europa, Inc.; Viva International, Inc.; Viva IP Corp.; and Miracle Optics (hereinafter collectively referred to as the "Pledgors").

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement dated August 1, 2006 (the "Trademark Security Agreement"), made by the Pledgors in favor of the Collateral Agent, security interests (the "Security Interests") were granted by the Pledgors to the Collateral Agent in certain Trademarks (as hereinafter defined); and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on September 7, 2006, at Reel 3385, Frame 0034; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interests in the Trademarks;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Credit Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby states as follows:

1. Patents: The term "Trademarks," as used herein, shall mean all of the Pledgors' (i) trademark and service mark registrations in the United States, including, without limitation, all of the registrations listed in Schedule A, (ii) applications for trademarks and services marks in the United States, including, without limitation, all of the applications listed in Schedule A, and (iii) all goodwill associated with the above-identified trademark and service mark registrations and applications.

2. Release of Security Interests: The Collateral Agent hereby terminates, releases and discharges its Security Interests in the Trademarks, and any right, title or interest of the Collateral Agent in such Trademarks shall hereby immediately cease and become void.

3. Authorization to USPTO: The Collateral Agent hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office to release the above-referenced Security Interests.

4. Further Assurances: At the request and sole expense of Pledgors, the Collateral Agent shall execute and deliver to the Pledgors any such additional documents as the Pledgors may reasonably request to evidence the termination and release of the Security Interests.
