**ASSIGNMENT OF TRADEMARKS AND

herewith, that it will execute any and all other instruments which may be necessary to perfect and evidence ASSIGNEE's ownership of the property and rights herein conveyed, that it will not assert any claim adverse to ASSIGNEE or its assigns' rights, titles and interests in the Trademarks and United States Registrations that, subject to any license agreement, it will not use the Trademarks in any way that could prejudice ASSIGNEE'S rights therein, and that it will not establish or seek to establish any rights in the Trademarks, including trademark registrations and applications.
