**CONFIRMATORY GRANT OF SECURITY INTEREST
IN UNITED STATES COPYRIGHTS, TRADEMARKS AND PATENTS**

THIS CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES COPYRIGHTS (the "Confirmatory Grant") is made effective as of July 18, 2016 by and from CHASE BRASS AND COPPER COMPANY, LLC (the "Grantor") to and in favor of JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the "Grantee") for itself and on behalf and for the benefit of the other Secured Parties (as defined in the Credit Agreement referenced below).

WHEREAS, Global Brass and Copper, a Delaware corporation, Global Brass and Copper Holdings Inc., a Delaware corporation, the lenders party thereto and the Grantee have entered into a Term Loan Credit Agreement dated as of July 18, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement").

WHEREAS, the Grantor and the other grantors from time to time party thereto have entered into a Pledge and Security Agreement dated as of July 18, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

WHEREAS, the Grantor owns the trademarks listed on Exhibit A attached hereto (the "Trademarks"), which Trademarks are pending or registered with the United States Patent and Trademark Office.

WHEREAS, the Grantor owns the patents listed on Exhibit B attached hereto (the "Patents" and, together with the Copyrights and Trademarks, the "Intellectual Property"), which Patents are pending or registered with the United States Patent and Trademark Office.

WHEREAS, the Grantor owns the copyrights listed on Exhibit C attached hereto (the "Copyrights"), which Copyrights are pending or registered with the United States Copyright Office.

WHEREAS, this Confirmatory Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to and are in addition to those set forth in the Security Agreement and the other Loan Documents, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined herein shall have the respective meanings given to them in the Credit Agreement.

2) The Security Interest.

(a) This Confirmatory Grant is made to secure the satisfactory performance and payment of all the Secured Obligations. Upon the termination of the Credit Agreement and all of the Secured Obligations have been indefeasibly paid and performed in full (or with respect to any outstanding Letters of Credit, such Letter of Credit has been cash collateralized as required by Section 2.06(j) of the Credit Agreement) other than contingent indemnification obligations as to which no claim has been made and no commitments of the Administrative Agent or the other Secured Parties which would give rise to any Secured Obligations are outstanding, the Grantee shall promptly execute, acknowledge, and deliver to the Grantor all reasonably requested instruments in writing or otherwise releasing the security interest in the Intellectual Property acquired under this Confirmatory Grant.


(b) The Grantor hereby grants to the Grantee a security interest in (1) all of the Grantor's right, title and interest in and to the Intellectual Property now owned or from time to time after the date hereof owned or acquired by the Grantor, together with (2) all proceeds and products of the Intellectual Property, (3) the goodwill associated with the Trademarks of such Intellectual Property and (4) all causes of action arising prior to or after the date hereof for infringement of the Intellectual Property or unfair competition regarding the same.

3) Counterparts. This Confirmatory Grant may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

4) Governing Law. This Confirmatory Grant and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the internal laws of the State of New York.
