Assignor requests the Commissioner of Patents and Trademarks of the United States or, in the case of the countries outside of the United States, the analogous individual or agency responsible for trademarks, service marks, trade names and assumed names, to record Assignee as owner of the Marks, including any variations thereof, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

4. Assignor agrees to cooperate with Assignee such that Assignee may enjoy to the fullest extent the rights conveyed hereunder. Such cooperation includes prompt execution of all papers that are deemed necessary or desired by Assignee to perfect in Assignee the conveyed rights or in order to consummate more effectively the transaction contemplated hereby.

5. The terms, covenants, and conditions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and/or other legal representatives, and shall be binding on the Assignor, its successors, and assigns and/or other legal representatives.
