**TRADEMARK SECURITY AGREEMENT RELEASE**

This TRADEMARK SECURITY AGREEMENT RELEASE (this "Release") is made effective as of June 2, 2016, by DEUTSCHE BANK TRUST COMPANY AMERICAS, in its capacity as Security Agent (the "Security Agent") in favor of ADVANCEPIERRE FOODS, INC.; ADVANCE BRANDS, LLC; ADVANCE FOOD COMPANY, INC.; BARBER FOODS, LLC; CLOVERVALE FARMS, LLC and ZARTIC, LLC ("Grantors" and each, a "Grantor").

**WITNESSETH:**

WHEREAS, pursuant to that certain First-Lien Credit Agreement dated as of October 10, 2012 (as amended, restated, supplemented, modified, renewed or extended from time to time, the "Credit Agreement") among Pierre Holdco, Inc., a Delaware corporation, AdvancePierre Foods, Inc., a Delaware corporation, as borrower ("Borrower"), the lenders party thereto as "Lenders" ("Lenders"), and the Administrative Agent (together with the Lenders, the "Lender Creditors"), the Lender Creditors have agreed to make certain financial accommodations available to Borrower from time to time pursuant to the terms and conditions thereof;

WHEREAS, in order to induce the Lender Creditors to enter into the Credit Agreement and the other Credit Documents and to induce the Lender Creditors to make financial accommodations to Borrower as provided for in the Credit Agreement, the Grantors agreed to grant a continuing security interest in and to the Collateral, including the Trademark Collateral (as defined below), in order to secure the prompt and complete payment, observance and performance of, among other things, the Secured Obligations, pursuant to that certain Security Agreement dated as of October 10, 2012 among the Grantors and the Security Agent (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, the Grantors have entered into certain Trademark Security Agreements, dated as of October 10, 2012 (as amended, restated, supplemented or otherwise modified from time to time, individually, a "Trademark Security Agreement" and collectively, the "Trademark Security Agreements") whereby the Grantors granted to the Security Agent a security interest in and to certain intellectual property of the Grantors;

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on October 15, 2012 at Reel 4881 and Frame 0618; Reel 4881 and Frame 0633; Reel 4881 and Frame 0179; Reel 4881 and Frame 0644; Reel 4881 and Frame 0657; and Reel 4881 and Frame 0666; and

WHEREAS, in accordance with the provisions of the Trademark Security Agreements, the Security Agent now desires to release its security interest in and to the Trademark Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the Credit Agreement.
2. RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL. The Security Agent hereby releases to the Grantors its security interest in such Grantors' Trademark Collateral

(as such term is defined in the Trademark Security Agreements), including the trademarks listed on Schedule I.

3. COUNTERPARTS. This Release may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument.

4. RECORDATION. The Security Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

5. GOVERNING LAW. **THE VALIDITY OF THIS RELEASE, THE CONSTRUCTION, INTERPRETATION, AND ENFORCEMENT HEREOF, AND THE RIGHTS OF THE PARTIES HERETO WITH RESPECT TO ALL MATTERS ARISING HEREUNDER OR RELATED HERETO SHALL BE DETERMINED UNDER, GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.**
