TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS AND PATENTS** (this “*Termination and Release*”) is granted as of July 21, 2016 by **THE PRIVATEBANK AND TRUST COMPANY** (the “*Agent*”), in favor of **TZ INSURANCE SOLUTIONS LLC**, a Delaware limited liability company (“*TZ*”), **TRANZSUBCO I CORP.**, a Delaware corporation (“*TRANZSUBCO*”), **VTH SOLUTIONS LLC**, a Delaware limited liability company (“*VTH*”), **TRUBRIDGE, INC.**, an Ohio corporation (“*TruBridge*”), and **TZ CANCELS, LLC**, a Delaware limited liability company (“*CanceLS*”), and together with TZ, Tranzsubco, and TruBridge individually, a “*Grantor*”, and collectively, the “*Grantors*”).

WHEREAS, TZ executed and delivered that certain Patent and Trademark Security Agreement, dated as of June 29, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*TZ Agreement*”), granting the Agent a security interest in and lien on certain Trademarks (and the respective goodwill of each) and Patents described and defined therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on January 31, 2013, at Reel 4953, Frame 0688;

WHEREAS, Tranzsubco executed and delivered that certain Patent and Trademark Security Agreement, dated as of June 29, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Tranzsubco Agreement*”), granting the Agent a security interest in and lien on certain Trademarks (and the respective goodwill of each) and Patents described and defined therein, which was recorded at the USPTO on January 31, 2013, at Reel 4953, Frame 0696;

WHEREAS, VTH executed and delivered that certain Patent and Trademark Security Agreement, dated as of October 10, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*VTH Agreement*”), granting the Agent a security interest in and lien on certain Trademarks (and the respective goodwill of each) and Patents described and defined therein, which was recorded at the USPTO on October 10, 2014, at Reel 5379, Frame 0368;

WHEREAS, TruBridge executed and delivered that certain Patent and Trademark Security Agreement, dated as of September 1, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*TruBridge Agreement*”), granting the Agent a security interest in and lien on certain Trademarks (and the respective goodwill of each) and Patents described and defined therein, which was recorded at the USPTO on September 1, 2015, at Reel 5614, Frame 0300;

WHEREAS, CanceLS executed and delivered that certain Patent and Trademark Security Agreement, dated as of November 6, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*CanceLS Agreement*” and together with the TZ Agreement, Tranzsubco Agreement, VTH Agreement and TruBridge Agreement, collectively, the “*Agreements*”), granting the Agent a security interest in and lien on certain Trademarks (and

the respective goodwill of each) and Patents described and defined therein, which was recorded at the USPTO on November 9, 2015, at Reel 5663, Frame 0624;

WHEREAS, the Grantors have requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Trademarks and Patents described in the Agreements (collectively, the “**IP**”) as herein provided; and

WHEREAS, the Grantors have requested that the Agent provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the IP as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:


1. terminates the Agreements and releases, terminates and discharges all liens and security interests in each of the Grantor’s right, title and interest in, to and under the IP, and all goodwill associated therewith, including the IP identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO by the Grantors.

This Termination and Release shall be a contract made under and governed by the internal laws of the State of New York applicable to contracts made and to be performed entirely within such State.
