NOTICE OF RELEASE OF SECURITY INTEREST

This Notice of Release of Security Interest (the "Release") is effective as of July 11, 2016, by SILICON VALLEY BANK (together with its successors, "Secured Party").

WHEREAS, reference is made to that certain Intellectual Property Security Agreement dated as of April 28, 2004 by and between COMDIAL CORPORATION, a Delaware corporation ("Comdial Corp") in favor of the Secured Party (the "First Security Agreement"), the Intellectual Property Security Agreement dated as of April 28, 2004 by and among COMDIAL ACQUISITION CORP., a Delaware corporation ("Comdial Acquisition"), COMDIAL BUSINESS COMMUNICATIONS CORPORATION, a Delaware corporation ("Comdial Business"), COMDIAL TELECOMMUNICATIONS INTERNATIONAL, INC., a Delaware corporation ("Comdial Telecommunications"), COMDIAL ENTERPRISE SOLUTIONS, INC., a Delaware corporation ("Comdial Enterprise"), AURORA SYSTEMS, INC., a Delaware corporation ("Aurora Systems"), ARRAY TELECOM CORPORATION, a Delaware corporation ("Array Telecom"), KEY VOICE TECHNOLOGIES, INC., a Delaware corporation ("Key Voice"), and COMDIAL REAL ESTATE CO., INC., a Maryland corporation ("Comdial Real Estate"), in favor of Secured Party (the "Second Security Agreement"), and the Amended and Restated Security Agreement dated as of July 3, 2014 by and between VERTICAL COMMUNICATIONS, INC., a Delaware corporation ("Vertical" and together with Comdial Corp, Comdial Acquisition, Comdial Business, Comdial Telecommunications, Comdial Enterprise, Aurora Systems, Array Telecom, Key Voice and Comdial Real Estate, collectively the "Grantors" and each individually referred to as a "Grantor") in favor of Secured Party (the "Third Security Agreement"); and

WHEREAS, pursuant to the First Security Agreement, the Second Security Agreement and the Third Security Agreement (collectively, the "Security Agreements"), the Grantors granted to the Secured Party a security interest in certain of the Grantors' assets, including, without limitation, the trademarks and patents ("Intellectual Property") owned by Grantors as described in each Security Agreement; and

WHEREAS, the First Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on June 25, 2004 at Reel/Frame 2879/0736, the Second Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on June 25, 2004 at Reel/Frame 2879/0726, and the Third Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on July 7, 2014 at Reel/Frame 5317/0429;

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreements, Secured Party hereby releases and remits, without any recourse, representation or warranty, any and all rights, title and interests in and to solely the Intellectual Property set forth on Exhibit A attached hereto, and hereby authorizes the Grantors or Grantors' authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release.
