**ARTICLES OF MERGER
OF
TEAVANA CORPORATION
INTO
STARBUCKS CORPORATION**

To the Secretary of State
State of Washington

Pursuant to the provisions of the Washington Business Corporation Act governing the merger of a foreign wholly-owned subsidiary business corporation into its domestic parent business corporation, the domestic parent business corporation hereinafter named does hereby submit the following articles of merger.

1. Starbucks Corporation, a Washington corporation, owns all of the issued and outstanding shares of stock of Teavana Corporation, a Georgia corporation.

2. Annexed hereto and made a part hereof is the Plan of Merger for merging Teavana Corporation with and into Starbucks Corporation as adopted by the Board of Directors of Starbucks Corporation on December 11, 2015.

3. Pursuant to Section 23B.11.040 of the Washington Business Corporation Act, approval of the Plan of Merger by the shareholders of Starbucks Corporation, the parent corporation, and Teavana Corporation, the merging subsidiary corporation, was not required.

4. This merger is permitted by the laws of Georgia under whose laws Teavana Corporation is incorporated and Teavana Corporation has complied with such laws in effecting this merger.

5. Starbucks Corporation will continue its existence as the surviving corporation under its present name pursuant to the provisions of the Washington Business Corporation Act.

6. The effective date of the merger herein provided for in the State of Washington shall be on May 20, 2016.

**PLAN OF MERGER
MERCING
TEAVANA CORPORATION, A GEORGIA CORPORATION
INTO
STARBUCKS CORPORATION, A WASHINGTON CORPORATION**

THIS PLAN OF MERGER has been duly adopted by Starbucks Corporation, a corporation organized under the laws of the State of Washington (the "Surviving Company"), by resolution of its Board of Directors.

1. The Surviving Company is the owner of all of the issued and outstanding shares of stock of Teavana Corporation, a corporation organized under the laws of the State of Georgia (the "Merging Company").

2. The Merging Company shall, pursuant to the provisions of the laws of the State of Washington and the laws of the State of Georgia, be merged with and into the Surviving Company, which shall be the surviving entity in the merger and which shall continue to exist under its present name and will succeed to and assume all the rights and obligations of the Merging Company pursuant to the provisions of the Washington Business Corporation Act (the "Merger"). The separate existence of the Merging Company shall cease at the effective time and date of the Merger in accordance with the provisions of the Georgia Corporations and Associations Act.

3. The Articles of Incorporation and the Bylaws of the Surviving Company at the effective time and date of the Merger shall continue in full force and effect until amended and changed in the manner prescribed by the provisions of the Washington Business Corporation Act.

4. The issued shares of capital stock of the Merging Company outstanding immediately before the effective time and date of the Merger shall be cancelled without consideration. The issued shares of capital stock of the Surviving Company outstanding immediately prior to the effective time and date of the Merger shall not be converted or exchanged in any manner, but they shall continue to represent issued and outstanding capital stock in the Surviving Company.

5. The proper officers and authorized persons of the Merging Company and of the Surviving Company, respectively, are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the Merger herein provided.

6. The Surviving Company, in its capacity as the owner of all of the issued and outstanding shares of stock of the Merging Company, hereby waives the mailing of a copy of the Plan of Merger to the Surviving Company otherwise provided for under the provisions of Section 23B.11.040 of the Washington Business Corporation Act.

7. The Merger shall become effective on May 20, 2016.
