8. MANNER IN WHICH TITLE OF TRUST ASSETS SHALL BE TAKEN. Title to trust assets should be taken in the following form: Ahmet Zappa and Diva Zappa, Trustees of the Zappa Family Trust Administrative Trust established by that certain Declaration of Trust dated November 15, 1990.
9. MANNER IN WHICH ACCOUNTS SHALL BE MANAGED. The acting Trustees of the Trust may manage, direct and/or execute trades, conduct banking activities, make deposits, withdrawals and endorsements on behalf of the Trust in any account maintained with any bank, trust company, savings and loan association, insurance company, stock brokerage firm or other similar institution.

10. NO REVOCATIONS, MODIFICATIONS OR AMENDMENTS. The Trust has not been revoked, modified, or amended in any manner that would cause the representations contained in this Certification of Trust to be incorrect.


10. SIGNED BY ALL CURRENTLY ACTING TRUSTEES. This Certification of Trust is being signed by all of the currently acting Trustees of the Trust.

11. ACCURACY. This Certification of Trust is a true and accurate statement of the matters referred to herein.



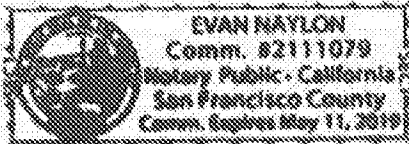

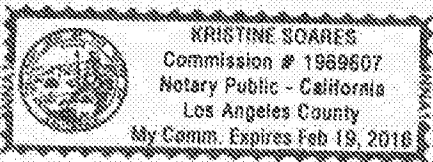
