## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of July 20<sup>th</sup>, 2016 ("Effective Date") by and between Dectron Inc. with its principal office at 3999 Côte-Vertu Blvd, Montreal, Quebec, H4R 1R2 ("Debtor"), and National Bank of Canada ("Secured Creditor").

**WHEREAS** pursuant to the terms and conditions of a certain agreement recorded on February 27, 2002 with the Canadian Intellectual Property Office and on April 11, 2002 with the United States Patent and Trademark Office, and entered into by and between Debtor and Secured Creditor (the "Agreement"), Debtor granted to Secured Creditor a security interest in and to the Debtor's right, title and interest in and to the trademark applications/registrations owned by Debtor (collectively, the "Collateral"), including, without limitation, the United States and Canadian trademark applications/registrations set forth on Schedule A attached hereto;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Creditor hereby terminates the Agreement and hereby terminates, cancels and releases any and all security interests it has against the Collateral.

Secured Creditor represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark applications or trademark registrations owned by Debtor, other than those of the foregoing applications or registrations set forth on Schedule A (attached hereto).

Secured Creditor shall take all further actions, and provide to Debtor, Debtor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Debtor to more fully and effectively effectuate the purposes of this Release.
