
I, ADNAN DURRANI, am the President of Mediterranean Snack Food Company, LLC ("Registrant").

1. I submit this affidavit to the Patent and Trademark Office ("PTO") to correct an error in how the Registrant is identified with respect to the trademark registrations for the following: (1) BEANSTALKS (U.S. Reg. No. 4819876), (2) TAPAZ 2 GO (U.S. Reg. No. 4445369), (3) TAPAZ 2 GO (U.S. Reg. No. 4445368), and (4) TAPAZ 2 GO (U.S. Reg. No. 4445367) (collectively, the "Trademarks").
2. When Registrant originally applied for registration of the Trademarks, Registrant erroneously identified itself as a New Jersey limited liability company. However, The Mediterranean Snack Food Company, LLC, a New Jersey limited liability corporation, did not exist on the filing date of the applications for the Trademarks.
3. Instead, on or about July 31, 2012, The Mediterranean Snack Food Company, LLC, the New Jersey limited liability company, was merged into Registrant (Mediterranean Snack Food Company, LLC), a Delaware limited liability company, and as of such date, the New Jersey limited liability company ceased to exist. Attached hereto as Exhibit A is the certificate of merger.
4. Registrant was, at the time it originally applied for registration of the above-referenced Trademarks, a Delaware limited liability company.
5. Accordingly, the Delaware limited liability company was the only Mediterranean Snack Food Company, LLC in existence as of the filing date of the applications for the above-referenced Trademarks, and should properly be reflected as the owner of the Trademarks.

Registrant now seeks: (i) to correct this mistake, which caused the registration for the Trademarks to issue in the name of a fictitious and non-existent entity; and (ii) to have the records of the PTO corrected to reflect that the Registrant is Mediterranean Snack Food Company, LLC, a Delaware limited liability company.

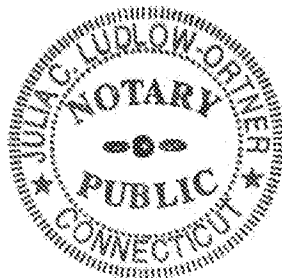
