**NOW, THEREFORE**, CSIS and CTI agree as follows and confirm that:



CSIS has assigned and transferred, and CTI has received and accepted, all of CSIS's rights, title and interest in the United States in and to the CSIS Marks and all the rights, claims and privileges pertaining to the CSIS Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the CSIS Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of CSIS in all matters related thereto.


CSIS hereby authorizes and requests the United States Commissioner of Patents and Trademarks to implement this Assignment.
