Pursuant to Section 252(c) of the
General Corporation Law of the State of Delaware

SugarCRM Inc., a Delaware corporation ("***SugarCRM Delaware***"), does hereby certify to the following facts relating to the merger (the "***Merger***") of SugarCRM Inc., a California corporation ("***SugarCRM California***"), with and into SugarCRM Delaware, with SugarCRM Delaware remaining as the surviving corporation of the Merger (the "***Surviving Corporation***"):

- FIRST: SugarCRM Delaware is incorporated pursuant to the General Corporation Law of the State of Delaware ("***DGCL***"). SugarCRM California is incorporated pursuant to the General Corporation Law of the State of California. SugarCRM Delaware and SugarCRM California are the constituent corporations in the Merger.
- SECOND: An Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by SugarCRM Delaware and SugarCRM California in accordance with the provisions of subsection (c) of Section 252 of the DGCL.
- THIRD: The name of the Surviving Corporation shall be SugarCRM Inc.
- FOURTH: Upon the effectiveness of the Merger, the certificate of incorporation of the Surviving Corporation shall be amended and restated to read in its entirety as set forth in the Restated Certificate of Incorporation attached hereto as **Attachment A**.
- FIFTH: The executed Agreement and Plan of Merger is on file at the principal place of business of SugarCRM Delaware, the Surviving Corporation, 10050 North Wolfe Road, SW2-130, Cupertino, CA 95104, United States of America.
- SIXTH: A copy of the executed Agreement and Plan of Merger will be furnished by SugarCRM Delaware, the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation of the Merger.
- SEVENTH: The authorized capital stock of SugarCRM California is 70,000,000 shares of Common Stock, \$0.00001 par value per share, and 31,865,176 shares of Preferred Stock, \$0.00001 par value per share.
- EIGHTH: The Surviving Corporation is a corporation formed and existing under the laws of Delaware.
- NINTH: This Certificate of Merger shall become effective upon filing.

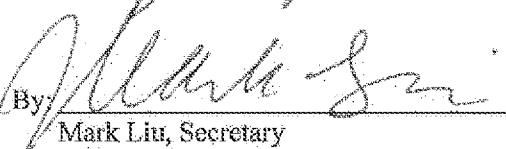
