INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of July 25, 2016, is made by Noven Pharmaceuticals, Inc., a Delaware corporation ("Noven") and Noven Therapeutics, LLC, a Delaware limited liability company and wholly owned subsidiary of Noven ("NT", each an "Assignor", and together the "Assignors").

WHEREAS, Assignors and Sebela International Limited, an Irish company resident in Bermuda ("Assignee"), are parties to that Asset Purchase Agreement, dated as of July 25, 2016 (the "Purchase Agreement"), providing for the execution and delivery of this Assignment by Assignors to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Assignor hereby agree as follows:

1. Defined Terms. Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Purchase Agreement.

2. Assignment. Subject to the terms and limitations set forth in the Purchase Agreement, each Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, all of such Assignor's right, title, and interest in and to the Assigned Intellectual Property, including, but not limited to such Assignor's right, title and interest in the Assigned Patents and Assigned Trademarks (including any associated goodwill) set forth on Schedule 1 as owned by such Assignor; all rights, interests, claims, and demands recoverable in law or equity that Assignor has or may have in profits and damages for past, present and future infringement or misappropriation of the Assigned Intellectual Property, including, but not limited to, the right to compromise, sue for and collect such profits and damages, the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made.

3. Consistency with Purchase Agreement. This Assignment shall be construed consistently with the Purchase Agreement and nothing in this Assignment, express or implied, is intended to supersede, modify, replace, amend, rescind, waive, expand or limit the Purchase Agreement. To the extent of any inconsistency between this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall control and prevail.

4. Counterparts. This Assignment and any amendment or modification may be executed in any number of counterparts (including via facsimile or electronic copy), each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.

5. Governing Law. This Assignment and all questions regarding its validity or interpretation, or the breach or performance of this Assignment, shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, without reference to conflict of law principles that would permit or require the application of the law of any other jurisdiction.

6. Miscellaneous. Articles XI and XII of the Purchase Agreement shall apply to this Assignment and are hereby incorporated by reference, *mutatis mutandis*, in this Assignment as if such provisions were fully set forth herein.
