TRADEMARK ASSIGNMENT

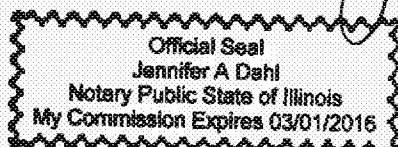
