


ORDER REQUIRING DISTRIBUTION AND RESOLVING OTHER MATTERS HEARD
BY THE COURT ON MARCH 28, 2016


THIS CAUSE came before the court for hearing on March 28, 2016. On October 6, 2015, this Court entered an Amended Order Setting Hearings and Establishing Deadlines which provided for dates and deadlines intended to direct this 2008 estate case toward closure. The final hearing on all pending matters including objections to the final accounting and petition for discharge was held on January 12, 2016. This Court's Order on January 12, 2016 Final Hearing resolved all pending matters, including overruling all objections to the final accounting and petition for discharge, and required the personal representative to file an Amended Plan of Distribution to include certain fees awarded at the January 12, 2016 hearing as well as correct previously miscalculated fee awards. The Amended Plan of Distribution was filed on February 5, 2016. On February 12, 2016, attorney Enwall on behalf of interested party Ellas Anthony McDaniel filed objections to the Amended Plan of Distribution. On March 14, 2016 Attorney Enwall also filed a Motion to Compel Compliance with Court Order and Motion for Attorney's Fees and Costs Incurred Since January 12, 2016. All three matters were properly before the Court for hearing on March 28, 2016. Having reviewed the pleadings and the court file, heard argument from counsel and being otherwise fully advised in the premises, the Court FINDS and ORDERS as follows:

1. Objections to Personal Representative's Amended Plan of Distribution filed February 12, 2016: **OVERRULED**. The Amended Plan of Distribution filed February 5, 2016 is approved. The personal representative shall immediately execute the Amended Plan of Distribution and provide proof of distribution **within 10 days** of the date of this order. On receipt of evidence that the estate has been distributed according to the Amended Plan of Distribution, the Court shall enter an order discharging the personal representative and releasing the surety on any bond.
2. Motion to Compel Compliance with Court Order filed March 14, 2016: The Court recognizes that it orally ordered that no payments from the estate would occur until

resolution of the pending appeal. However, on March 31, 2016 notice of dismissal of the appeal was filed with the Court. Therefore, because the disputed payment amount raised by this Motion to Compel is included as an authorized distribution in the Amended Plan of Distribution already approved by this Court under paragraph 1, this motion is deemed **MOOT**.

3. Motion for Attorney's Fees and Costs Incurred Since January 12, 2016 filed March 14, 2016: The Court finds that for the time period in question Attorney Enwall has not rendered services to the estate which should be rewarded by reasonable compensation from the estate. See Fla. Stat. 733.106(3). Therefore, this motion is **DENIED**.


