**RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT (this “Release”), dated as of July 21, 2016, is made by **U.S. BANK NATIONAL ASSOCIATION**, a national banking association, in its capacity as agent (together with its successors and assigns in such capacity, “Agent”) for the Lender Group and the Bank Product Providers (as such terms are defined in the Agreement defined below), and is as follows:

WHEREAS, RelaDyne LLC, a Delaware limited liability company; Mid-Town Petroleum Acquisition LLC, a Delaware limited liability company; Four O Corporation, an Ohio corporation; Paulson Oil Acquisition Company LLC, a Delaware limited liability company; Sunwell Corporation, a Texas corporation; and Palatine Oil, LLC, a Delaware limited liability company (each a “Grantor” and collectively, the “Grantors”), and Agent are parties to that certain Amended and Restated Trademark Security Agreement dated as of May 27, 2016, which was recorded with The United States Patent and Trademark Office on June 8, 2016, in its records at Reel 5810, Frame 0857 as to RelaDyne LLC; at Reel 5809, Frame 0294 as to Mid-Town Petroleum Acquisition LLC; at Reel 5809, Frame 0309 as to Four O Corporation; at Reel 5808, Frame 0545 as to Paulson Oil Acquisition Company LLC; at Reel 5809, Frame 0321 as to Sunwell Corporation; and at Reel 5808, Frame 0966 LLC and corrective assignment recorded on June 17, 2016 at Reel 5816, Frame 0356 as to Palatine Oil, LLC (the “Agreement”); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to Agent a security interest in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral, including, without limitation: (a) all Trademarks (attached hereto and made a part hereof as Exhibit A); and (i) all renewals of each thereof, (ii) all income, royalties, damages and payments now or hereafter due or payable with respect thereto, including damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, and (iv) all rights corresponding thereto throughout the world; (b) the goodwill of such Grantor’s business connected with and symbolized by the Trademarks; and (c) all proceeds of the foregoing; and

WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreement.
