The undersigned, for the purposes of filing articles of merger pursuant to Title 18, Section 2054 of the Oklahoma Limited Liability Company Act (the "Act"), does hereby execute the following articles of merger:

1. The name and jurisdiction of formation or organization of each of the constituent entities to the merger are:
 - (a) Great Plains Oilfield Rental, L.L.C., an Oklahoma limited liability company (the "Surviving Company"); and
 - (b) Oilfield Trucking Solutions, L.L.C., an Oklahoma limited liability company ("OTS").
2. A merger agreement has been approved and executed by the Surviving Company and OTS as required by the Act and the governing documents of the Surviving Company and OTS.
3. An executed merger agreement is on file at 777 NW 63rd Street, Oklahoma City, OK 73116, which is the address of the principal place of business of the Surviving Company.
4. A copy of the merger agreement will be furnished by the Surviving Company, on written request and without cost, to any shareholder or equity holder of each party to the merger.
5. The surviving entity in the merger shall be the Surviving Company.
6. The name of the Surviving Company shall be Great Plains Oilfield Rental, L.L.C.
7. The articles of organization of the Surviving Company prior to the Effective Time shall be the articles of organization of the Surviving Company on and after the Effective Time.
8. The merger is to become effective as of 12:00 am Oklahoma City time on January 1, 2016 (the "Effective Time").
