TRADEMARK SECURITY AGREEMENT

This Trademark Security Agreement, is effective as of the 6th day of July, 2016 ("Trademark Security Agreement") by and between OUHLALA GOURMET CORP., a Florida corporation, with its chief executive office at 2555 S. LeJeune Road, Suite 1011, Coral Gables, Florida, 33134-5201, ("Customer"), and BOWMAN ANDROS PRODUCTS, LLC, (organized under the laws of Delaware) having offices in Virginia, located at 10119 Old Valley Pike, P.O. Box 817, Mount Jackson, Virginia 22842-0817 ("Andros").

RECITALS

This Trademark Security Agreement is a supplement to the Addendum No. 4 to Supply Agreement (Guarantee and Grant of Security Interest) dated as of the date July 16, 2016 between Customer and Andros (the "Agreement").

All capitalized terms not defined herein shall have the definitions ascribed to them in the Agreement, and are incorporated herein by reference. If there is a conflict between the definitions, terms or provisions of this Trademark Security Agreement and the Agreement, the definitions, terms or provisions of the Agreement shall control.

This Trademark Security Agreement is executed for the purpose of filing a short form security agreement in the United States Patent and Trademark Office (the "USPTO") and the US Copyright Office, which sets forth the Customer's pledge of certain of its intellectual property as secured in the Agreement.

GRANT OF SECURITY INTEREST

The Customer hereby grants to Andros a security interest and lien in all of Customer's general intangibles, including trade recipes, trade secrets (including Customer list) Goodwill and Trademarks both registered and both registered and common law trademarks, including but not limited to the Trademarks described in Exhibit ⁶ attached hereto ("Collateral"). The Collateral includes

(a) All trademarks, both registered and common law trademarks, including without limitation, the Buddy Fruits Brand Name and Logo (include graphic) and all associated trademark registrations therefore as well as the good will associated therewith except as to Intention To Use trademark applications which are not to be considered Collateral until the use of the trademark is established (Trademarks).

(b) All associated trade recipes, trade secrets (including customer lists) and Goodwill.

The "Collateral" shall include Customer's present and future right, title and interest in and to the following items, together with any and all rights corresponding or similar to the following items under the applicable law.

(a) All copyrights whether statutory or arise under the common law relating to the packaging, advertising and promotional materials for the goods sold under the Trademarks ("Copyrights");

(b) All rights of action on account of past, present and future unauthorized use or infringement of any of said Trademark or Copyrights;

(c) All rights to damages and payments for past or future infringement of the Trademarks or Copyrights.

REPRESENTATIONS, WARRANTIES, COVENANTS AND MISCELLANEOUS

All other terms, conditions, agreements, obligations, representations, warranties, covenants, definitions, exhibits and miscellaneous terms, conditions, agreements and obligations set forth in the Agreement are restated and incorporated herein by reference.

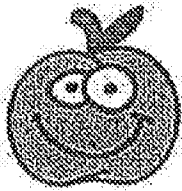

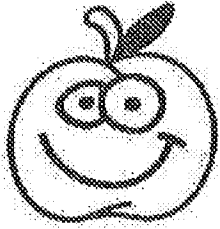
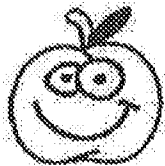
